WHEREAS, Section 4.2(e) of the Declaration provides that the Assignor shall have the authority to enter into agreements with another District (as defined in the Declaration, which includes the Assignee) to (i) enforce all or part of Supplemental Covenants and Easements (as defined in the Declaration), (ii) maintain, and repair damage to, the Easements (as defined in the Declaration), (iii) maintain, repair, and replace, as necessary, the Perimeter Fences and the Auto Courts (both as defined in the Declaration), and (iv) to provide any other services or perform any other functions of the Assignor as set forth in the Declaration; and

WHEREAS, Assignor desires to assign all of its rights and obligations under the Declaration to the Assignee, and the Assignee desires to accept such assignment; and
